She has worked at UW Medicine for the past 17 years, where she was steadily promoted from Associate Administrator, Patient Care Services to Chief Nursing Officer, to Chief Operating Officer and Executive Director at Harborview Medical Center prior to being promoted to the position of Chief Health System Officer, UW Medicine and Vice President for Medical Affairs, UW in 2007. In this position she is responsible for all clinical entities in UW Medicine including Harborview Medical Center, UW Medical Center, Northwest Hospital, Valley Medical Center, UW Neighborhood Clinics, UW Physicians, Airlift Northwest & Enterprise Shared Services of Information Technology, Pharmacy, Human Resources, News, Community Relations and Marketing.

Prior to joining UW Medicine, Johnese worked in progressive leadership positions at the University of California Davis Medical Center and the University of Pittsburgh, Presbyterian Medical Center. She holds a clinical faculty member appointment in Biobehavioral
